





has received, she noted, it has been very encouraging and supportive, though some believe that since the homeschool ruling came as part of a divorce settlement, the issue of homeschooling itself has been somewhat obscured.

She has announced she will appeal the ruling but they are not yet on the docket.

Mrs. Mills, who does not believe in divorce, reluctantly filed for divorce in October 2008 after repeated instances of her husband's adultery. Confronted by her, he denied any affairs, yet continued a romantic relationship with his tennis partner. In December, he rented a house less than half a mile away, but chose not to move out of the family home until mid-March, 2009, causing emotional trauma and stress in the home. Later, under oath, he admitted to adultery, a crime in NC. The Mills' children are Dana 12, Jason 11 and Daniel 10.

According to court papers, Mr. Mills told the judge his wife became emotionally estranged following a 2005 conference she attended at the Solid Doctrine Church in Washington State. When she returned and discussed removing the children from public school to homeschool them, he was disinclined but temporarily agreed, admitting they were doing poorly in public school. After four years of homeschooling, one child is now learning at grade level and the other two are learning at two grades above their grade levels. All three want to continue homeschooling, and are upset they must return to public school. Judging from the immediate public outcry, so are legions of homeschoolers across the country. A campaign was launched to have Judge Mangum removed from the case.

Judge Mangum's ruling had not only granted Mr. Mills his desire to return the children to public schools, but also allowed Mr. Mills to pay the minimum amount of child support, causing


financial hardship for his wife and children. By returning the children to public school, the judge effectively frees/forces Mrs. Mills to go into the workforce, thus enabling Mr. Mills to pay less child support. Although Mr. Mills makes over \$120,000 a year, or \$9400 per month, the judge required that he pay only \$1400 per month in child support.

Following days of public anger and outrage over his sending homeschooled children back into public school, Judge Mangum wrote a Temporary Child Custody order dated March 17th, in which he justified his decision by quoting extensively from the 11-13 affidavits supplied by those sympathetic to Mr. Mills. Neither Mrs. Mills' rebuttals to those, nor any of her 37 supportive affidavits were quoted. He stipulated equal child custody, with each parent having the children on alternate weeks. Until Mrs. Mills completes the current, final term of homeschooling, on the weeks Mr. Mills has custody, he must transport them to their mother's residence at 8:00 a. m., and she must return them at 6: 00 p. m.

Accused of legislating from the bench, Judge Mangum defended his decision to return the children to public school, saying "it is in

their best interest", will make them "more well rounded", and will be good for "socialization". (Mrs. Mills has provided much evidence in 37 affidavits that they are already well socialized.) He said, "It will do them a great benefit to be in the public schools, and they will challenge some of the ideas that you've taught them (emphasis added) and they could learn from that and make them stronger."

Some of the affidavits provided to the court on behalf of Mr. Mills came from Mrs. Mills' parents and a sister in AZ, as well as some of her long-time friends including her maid of honor. They testified of their concerns about Mrs. Mills' involvement with the Sound Doctrine Church and the effect it is having on the children's safety and emotional stability. Other affidavits presented on Mr. Mills' behalf were by disgruntled former members of the Sound Doctrine Church who variously claimed that the Church is run by fear and manipulation, that members' commitment is tested by harassing them to give more money or risk proving they "don't love God enough", and that Church leaders Tim and Carla Williams mentally abuse members. Others pointed to the Williams's unusual desire to be called variations of Mother



and Father, Grandmother and Grandfather by church members including Venessa and her children. Some critics characterized the Church as a "cult" whose leaders repeatedly cause discord between family members, thus ruining relationships. Others recounted personal experiences with Church leadership and policies which seemed harsh or inappropriate.

When contacted about these allegations, the Sound Doctrine Church categorically denied them all, calling them gossip and slander, untruthful, and resulting from bias and misunderstandings. Gossip and the Gospel, by former pastor Tim Williams, may be downloaded at their website (sdoctrinechurch.org). The web-

site indicates the current Pastor and Assistant Pastor as Josiah Williams and Joshua Williams. Judge Mangum had found that part of the daily activity of the Mills children included "frequent communication via phone and web cam" with people at the Church in Washington State. Mr. Mills, who disapproved, said he had been unaware that part of the time being devoted to the children's homeschooling curriculum was comprised of instruction from a Church member in Washington State.

Mrs. Mills testified that her husband is a liar, an adulterer, a poor role model, and a bad father. Mr. Mills admitted his wife's good job of homeschooling the children and said she is a good mother, though expressed concern that his children have sometimes shown fear of her. He related an incident about a time she refused her 9 year old son's request to use the bathroom before finishing the dishes, causing humiliation when he urinated

the children and his mistress.

Nevertheless, not until Judge Mangum suffered the slings and arrows of public outrage over his order to remove three "thriving" children from homeschooling,

through his pants onto the kitchen

floor.

did he seek to divert attention from the issue of homeschooling to the issue of Mrs. Mills' involvement in the Sound Doctrine Church. The several additional pages of quotes from affidavits which suddenly appeared in his Temporary Custody Order had not been in the initial written draft of the verbal order prepared for the judge'signature by Mr. Mills' attorney.

Relating mostly to the Sound Doctrine Church, the affidavits consist entirely of "malicious gossip, insinuation, and slander", according to Robyn Williams, a friend of Venessa's who is also a conservative, stay-at-home Christian mother, homeschools her four children, and is certified to teach in three states. Robyn undertook to defend Venessa by establishing a blog (HSinjustice.com) where frequent updates appear about the case. Judge Mangum's oral (video) and two written court orders may be downloaded from that site. It suggests that more information may be found on the Christian

the court failed to consider the possibility that friends and family of Mrs. Mills may have rejected her when she joined the Sound Doctrine Church and became a "changed" person after adopting new religious beliefs which were foreign to them, as sometime occurs. Mr. Mills complained of becoming miserable in his formerly happy marriage after she began withdrawing emotionally, largely limiting her conversation to "quoting scripture and religious rhetoric".

The court also ordered a comprehensive custody evaluation of both parties and children to be conducted by Dr. Helen Brantley and her team at the UNC Forensic Psychiatry Service. No outside testimony is allowed at UNC proceedings, and Dr. Brantley and her team are known to be "pro-father". Not surprisingly, this evaluator was selected by Mr. Mills' attorney over the objection of Mrs. Mills' attorney. All the affidavits were ordered to be made available for the mental assessment and the custody evaluation.

It would seem that by highlighting Venessa Mills' religious beliefs and those of a small church on the other side of the country, Judge Mangum has somewhat succeeded in diverting attention from his initial ruling about homeschooling. But Robyn Williams urges those interested in "learning the truth" about the Church to access its website. She alleges that diversionary tactics have turned the entire matter away from the central issue of homeschooling to a "trial by gossip", and quotes Proverbs 18:8: "The words of a gossip are like choice morsels; they go down to a man's inmost parts."

On the other hand, says Ian Slater, a spokesman for the VA based Home School Legal Defense Association, which assists homeschool parents with legal problems, "It's a tragedy of divorce, but we don't see any broad implications."

Mrs. Mills had requested the Court to limit Mr. Mills' custody to nine hours a week, no overnights or Sunday visits, no phone calls to the children unless scheduled in advance, and no contact, while in his custody, with ex-Church members or anyone else hostile to the Church. The court rejected these demands when issuing its equal custody ruling. There was no censure of Mr. Mills' adultery, except he may not allow contact between

In addition, and "due to her family and friends' concerns", Judge Mangum ordered only Mrs. Mills to undergo a mental assessment begun within 30 days. Apparently,

too nice to Judge? Mal. 2:17 You make God tired with all your talk. "How do we tire him out?" you ask. By saying, "God loves sinners and sin alike. God loves all." And also by saying, "Judgment? God's too nice to judge."

We are nice Christians who attend nice churches that are killing America. We are Christians who promote a God that is, "too nice to judge." 



New Hampshire Considers 'Bathroom Bill'

(EP News)--New Hampshire's House Judiciary Subcommittee voted 3-2 to pass a bill that would open all public restrooms and locker rooms to people of the opposite sex. Family advocates are concerned that by adding the words "gender expression" into the list of anti-discrimination laws, it will make New Hampshire's public bathrooms a haven for sexual predators. Last June, Colorado passed a 'bathroom bill,' and shortly thereafter reports came in from women who were uncomfortable that men were using their restrooms. Pennsylvania is considering a similar bill.

Connecticut Legislation Targets Catholic Church

(EP News)--The "biggest political firestorm" of Connecticut's legislative session ended when the legislature tabled a bill that would have altered the structure of the Catholic Church in the state. Representatives had introduced a bill that would have installed a board of laymen to govern the church, usurping the church's structure of bishops and archbishops. "Our Church is facing an unprecedented intrusion by the state Legislature into our own internal affairs," Bridgeport Bishop William Lori told supporters last week. "It is a grave violation of religious liberty." The Judiciary Committee apparently agreed, and issued a statement saying it would "table any further consideration of this bill for the duration of this session."

Religion in America is on the Decline

(EP News)--In a 2008 study, 15 percent of Americans said they had no religion. That's an increase from 8.2 percent in 1990, according to the American Religious Identification Survey from Trinity College in Hartford, Conn. "Americans are slowly becoming less Christian. The challenge to Christianity does not come from other world religions or new religious movements, but rather from a rejection of all organized religions," said the report. In the latest survey, three out of four Americans called themselves Christian. In 1990, the figure was closer to nine out of 10. The most notable declines in the report came from mainline Protestant churches.

Howard Dayton, CEO of Crown Financial Ministries, pointed out one of the keys to financial freedom. "Learn to be content with what we have, instead of going out and buying things that we don't really need," he said. Dayton said it's also important to stay in contact with creditors. "It's been proven that creditors are much more willing to work with you, to seek to have some creative solution, if they feel you're actually going to make an effort to pay them," he said.

National Day of Prayer under Attack from Atheists

(EP News)--More than 50 years after it was made official by a joint resolution of Congress, the National Day of Prayer is being threatened by a group of atheists. The Freedom From Religion Foundation has filed a federal lawsuit, saying the National Day of Prayer is unconstitutional and creates a "hostile environment for nonbelievers." The Alliance Defense Fund will defend the National Day of Prayer Task Force. "The lawsuit will not keep us from responding to our call to ask Americans to intercede in prayer for our nation's leaders and their families," said Brian Toon, vice chairman of the NDP Task Force. "We pray without fear of retribution." The National Day of Prayer falls on the first Thursday of May -- May 7 this year.

TEA'd off Americans urged to protest

(**OneNewsNow**) A pro-family organization is planning TEA parties nationwide on April 15 -but the events, designed to send a strong message to the White House and Congress, won't be sit-down affairs.

The rallies are called Taxed Enough Already, or TEA, parties that will be held in 1,000 cities across the nation. People are being asked to gather at their city hall during the lunch hour on Tax Day. Similar gatherings have taken place in cities across the U.S., as tens of thousands have turned out to protest wasteful government spending and President Barack Obama's "stimulus" package.

Don Wildmon, founder and chairman of the sponsoring American Family Association, says the TEA parties have touched a nerve with average Americans.

"There's a tax rebellion coming if Congress and the president do not deal properly with this," says Wildmon. "I think that President Obama has gotten himself a problem that is above his pay grade -- and we're justhopingthatpeoplewillrespond." In a press release, Wildmon says Washington's economic solution thus far could have detrimental effects on families for generations. "We cannot spend our way out of debt," states the AFA leader, "and we find it immoral to pile debt on our great-grandchildren."

The April protests are inspired by the Boston Tea Party in December 1773, an incident which protested British taxation on the American colonies without representation in Parliament. Rhode Islanders can protest at the Statehouse, April 15th from 12-3pm. Massachusetts has 4 Tea Parties planned, 3 in Boston and 1 in Worcester. Check TeaPartyDay.com. for details.

Texas Appeals Court Upholds Moment-of-Silence Law

(EPNews)--Afederal appeals court on March 16 upheld a Texas law that allows public school students to observe a 60-second moment of silence following the Pledge of Allegiance. A three-judge panel from the 5th U.S. Circuit Court of Appeals in New Orleans ruled the moment of silence – one minute for students to reflect, pray, meditate or engage in silent activity – is constitutional.

In 2007, some parents sued, claiming the requirement to observe a moment of silent "causes harm" to their children and violates the First Amendment.

David Cortman, senior counsel

for the Alliance Defense Fund, said no student is compelled to pray under the Texas law. "A moment of silence is not a government endorsement of religion just because someone might use the time for prayer," he said. "The 5th Circuit was right to uphold the district court's determination that the law is not an establishment of religion."

Kelly Shackelford, chief counsel for Liberty Legal Institute, said the law is about freedom. "Students have the freedom to pray, meditate or simply think about their day," he said. "It took real intolerance for someone to sue to try to stop students from choosing prayer as their option."

Texas Attorney General Greg Abbott also defended the court's decision. "The United States Constitution plainly protects young Texans' right to observe a moment of silence before school each morning," Abbott said in a news release. "In an age where children are bombarded with distractions, beginning each school day with a moment of silence offers a welcome moment of quiet contemplation."

Twenty-six states have momentof-silence laws, including Rhode Island and Massachusetts.

Is Media Ignoring Adult Stem-Cell Successes?

(EP News)--Researchers in California and Ecuador have discovered that non-controversial adult stem cells from bone marrow can be used to treat patients with spinal-cord injuries. More than 50 patients with spinal injuries were injected with their own bonemarrow cells. To date, the patients have reported significant improvement and a better quality of life without serious complications.

This is just one of three recently published studies that demonstrate how adult stem cells are treating patients with spinal cord injury. Ironically, no one from the mainstream media reported any of these successes.

Dr. David Prentice, senior fellow for life sciences at the Family Research Council, said the successful treatments should be getting a lot more exposure. "There have been three groups now who have successfully treated patients – not rats or mice – with adult stem cells from the patient's own body," he said. "It's sad that people would continue to push use of embryos because that's actually obsolete science now. But, especially if we consider the patients first, we ought to be pouring all of our resources on the ethical and successful adult stem cells."

Instead, the mainstream media covered the news that biotechnology company Geron received permission from the FDA to conduct the first human clinical trial to see if embryonic stem cells can treat spinal-cord injuries. The harvesting of embryonic stem cells always requires the destruction of human life.

The FDA announced the decision to allow the life-destroying research just days after Obama was sworn into office.

Wesley J. Smith, senior fellow at the Discovery Institute, addressed the blatant media cover-up on his blog. "Geron's future human trial made huge news. But a successful human treatment for the same condition has been ignored by the mainstream media," he wrote. "Why the news blockade? Wrong kind of stem cells, apparently."

Dawn Vargo, bioethics analyst for Focus on the Family Action, said she is tired of adult stem cells getting ignored: "This is just further evidence that some members of the media continue to promote the agenda of embryonic stem cell research – at the cost of young human lives and at the cost, and even detriment, of helping patients."

Airport to tag passengers

Airport security chiefs and efficiency geeks will be able to keep close tabs on airport passengers by tagging them with a high powered radio chip developed at the University of Central London.

The technology is to be trialled in Debrecen Airport in Hungary after being in development for two-anda-half years by University College London as part of an EU-funded consortium called Optag.

Dr Paul Brennan, of UCL's antennas and radar group, said his team had developed a radio frequency identification tag far in advance of any that had been used to now to label supermarket produce.

People will be told to wear radio tags round their necks when they get to the airport. The tag would notify a computer system of their identity and whereabouts. The system would then track their activities in the airport using a network of high definition cameras.

"[The tags] have got a long range, of 10m to 20m," said Brennan, "and the system has been designed so the tag can be located to within a metre, and it can locate thousands of tags in one area at a given time."

RFID tags can normally only transmit their presence to readers a few centimetres away, while their location is difficult to grasp.

The project, called "Improving

airport efficiency, security and passenger flow by enhanced passenger monitoring," is using €2m of European funding so airports can herd people through the airport system.

Colin Brooks, Optag co-ordinator, said the trial would determine if the tags would be feasible in the light of obvious problems, such as the possibility that people might ditch their tags to avoid detection, or swap them with another person.

One solution might be to require people to use their tags to get through gates placed throughout the airport, he said. Perhaps a little like a shepherd might gate off his pasture and check the tags on his sheep as they passed into this field. ®

New UK Immigration Rules Leave Christians Confused

LONDON – Foreign Christian musicians and missionaries to the United Kingdom could be deported if they are not sponsored by a licensed organization and do not obtain the necessary visas, according to new immigration rules.

Early in March, Colorado-based Christian singer Don Francisco was refused entry into London and a team of missionaries from Arkansas were denied entry to Scotland after being told they needed work visas to enter the country.

Francisco arrived at Heathrow Airport to take part in the Christian musical "Why Good Friday," in which ten of his songs are included. Upon arrival he was detained, fingerprinted and escorted onto a flight back to the United States after officials claimed he did not have the proper paperwork.

Francisco, who has traveled throughout the United Kingdom for 30 years without trouble, said, "I felt like they were looking for a reason to keep me out," accord-

ing to the Pentecostal publication Charisma. Anyone who goes into England from this point on for any reason other [than] to be a tourist and just spend money had better have their ducks in a row."

Just the day before, a Master's Commission team from Arkansas was refused admission to Scotland after immigration officials found that they would be volunteering at soup kitchens in partnership with Assemblies of God churches in Edinburgh.

"She told us that we'd have to have a work visa," said Craig Johnson, associate youth minister at Harvest Time Church in Arkansas. "So essentially you can stay [in the UK] as a tourist for six months, but if you want to volunteer some of your time working in a soup kitchen, you have to have a work visa." Johnson added that instead of being escorted to a U.S. flight, the chief immigration officer could have let them through.

"The [immigration] team kept apologizing to us profusely. The [chief immigration officer] had the power to just discretionally wave us through. She was just doing her job; I understand that. But discretionally she could have waved us

Daniel Webster, parliamentary officer of the Evangelical Alliance, said the new immigration regulations had been introduced last November to counter illegal immigration and the threat of terrorism. The new rules, he said, had left many ministers and organizations confused.

through."

"The recent cases highlight just how complex these cases are and the urgent need for churches and ministries to be kept up to date. The Evangelical Alliance is working on a full analysis to help churches better understand the law so that this does not happen again," he said.

Christian artist Francisco added that he still hoped to take part in the musical but said, "My main concern is that this one misinterpretation and misapplication of immigration law will result in my being unable to return to the UK in the future. One question that is always asked at a border is, 'Have you ever been denied entry into this country?' Unless this present situation is reversed, my truthful reply would probably result in yet another denial of entry."

Papal Kotel Visit May Bar Jews

By Tzvi Ben Gedalyahu (Israel Today) The planned visit by Pope Benedict XVI to the Western Wall (Kotel) may force a ban on Jews from praying there for the first time since the holy site was restored to Israel after 2.000 years. Pope Benedict has said his visit to Israel in mid-May is devoted to "unity' and "peace."

Security officials have been discussing the issue with Western Wall Rabbi Shmuel Rabinowitz, who said he is vehemently opposed to the idea. Government authorities responsible for the safety of the Pope want to clear the area from the evening before his visit until he leaves.

"The Kotel must be open during the entire visit for every person who wants to pray," Rabbi Rabinowitz said. "Jews have been praying at the Kotel for almost 42 years. There is no preference

of one person over another."

Jews were banned from visiting the Western Wall during the Jordanian occupation of eastern Jerusalem. Jordan also closed off all of the Christian churches, and Israel re-opened all religious sites to all faiths after recovering all of Jerusalem in the Six-Day War in 1967.

Pope John Paul II visited the Western Wall in March 2000 and followed the tradition of placing a prayer between the cracks of the Wall. It stated, "God of our fathers, you chose Abraham and his descendants to bring your Name to the Nations. We are deeply saddened by the behavior of those who in the course of history have caused these children of yours to suffer. And asking Your forgiveness, we wish to commit ourselves to genuine brotherhood with the people of the Covenant."

Big Pharma CEO Fakes Cancer while Pill-Pushing Doctor Fakes Clinical Trial Results for Bextra, Effexor and Celebrex

(NaturalNews) The culture of deceit and fraud that permeates conventional medicine became even more apparent today with the announcement that Howard Richman, the former vice president of a pharmaceutical company named *Biopure*, faked his own cancer and even impersonated a doctor in order to convince a federal judge that he was dying from colon cancer.

This bizarre deceit was an effort by Richman to squirm out of an SEC lawsuit that accused Richman of misleading investors. According to the Associated Press, Richman misled investors about the potential for FDA approval of a blood replacement product called Hemopure, which is made from cow's blood. By faking his own cancer and forging a doctor's note, Richman was able to get a postponement of judgment in the SEC lawsuit, which effectively ended the legal action he would have otherwise faced.

It all makes you wonder just how low the integrity standards really are at drug companies these days. If a highly-paid executive can fake his own cancer in order to avoid a lawsuit brought against him because he lied to investors, what other sorts of fabrications and deceits might be going on at these companies?

Faking clinical trial data for Vioxx and Celebrex

Meanwhile, a researcher at *Baystate Medical Center* in Mas-

sachusetts, Dr. Scott Reuben, was found to have faked the data used in 21 "scientific" papers published in peer-reviewed medical journals from 1996 - 2008.

The Associated Press has recently reported that journals have begun retracting papers authored by Dr. Reuben. The journal Anesthesia & Analgesia has retracted 10 studies authored by Dr. Reuben, and the journal Anesthesiology has also started retracting studies.

But the damage has already been done: Dr. Reuben's work was reportedly relied on very heavily by pill-pushing doctors and medication advocates, who cited his studies to "prove" these drugs are safe and effective. In reality, though, **it was all just made up!**

This is actually the story on just about everything Big Pharma pushes these days: It's all just fiction shrouded in scientificsounding language, led by dishonest, corrupt drug company CEOs and deceitful doctors who lie to the world in order to make more money pushing dangerous prescription medications.

Even when drug company executives aren't lying to their investors or lying to judges, they're still lying to the FDA and their own customers about the safety of their drugs. Through the cherrypicking of drug trials (and the burying of negative results), they lie to the entire scientific community about the real dangers of

SUPREME COURT STRIKES DOWN FDA PRE-EMPTION

In a stunning and unexpected 6-3 ruling the right-leaning Supreme Court went against the wishes of the last president, took the wind out of the sails of health care reform of the current president, sent irresponsible Big Pharma a major wake up call, and bluntly told the arrogant FDA that they are indeed not above the rule of law. It is a major victory for every American citizen.

Central to the issue is a power struggle between the federal government and states, which in this situation meant the federal government authority to pre-empt your state rights to sue if you are injured by a drug. The FDA, acting on behalf of the Bush administration and on the side of Big Pharma, has helped tie up thousands of drug injury lawsuits across the country. The FDA, who is supposed to be protecting consumers from drug injury and ensuring a correct risk/safety picture for any person taking a drug, was instead trying to shirk their responsibility and simply claim that Americans had no right to sue.

This convoluted attempt by the FDA to undermine consumer safety was one of the main themes in my 2006 book, *Fight for Your Health: Exposing the FDA's Betrayal of America*. The Bush Administration had intentionally appointed anti-safety people in high positions

within the FDA, starting with its Chief Counsel, Daniel Troy (and continued as a legal phi-

losophy after Troy was forced out for his Big Pharma connections). Troy set in motion the legal problem the Supreme Court just decided.

During the final years of the Bush

intoxication, the drug companies hilariously try to convince people they're somehow getting healthier by popping patented pills.

But the results speak for themselves: Big Pharma is a big lie, and the people pushing the Big Pharma agenda are,

administration cancer industry insider Andrew von Eschenbach, MD, was appointed to run the FDA, and Wall Street insider, Scott Gottlieb, MD, was second in command. These individuals sought to fully implement the FDA label as senior to any rights of citizens. Their intention was to make sure that new biotech drugs would be protected from lawsuits, as the FDA wanted to speed new and even more dangerous drugs onto the market so as to foster the development of the biotech industry. In essence, the FDA management wanted to turn the American

public into one large clinical experiment, with no right of recourse when injured.

This was occurring against a backdrop wherein the FDA couldn't even name all the drugs currently on the market, had failed to demand required aftermarket follow up safety testing

on drugs, and had intentionally withheld safety information on existing drugs from the public. The current situation with drugs is that almost no drug, even blockbusters and those in use for decades, have an accurate risk/benefit profile.

nitude, which is a main reason over 100,000 Americans are killed every year and over 3 million are injured so seriously they need hospital care (ironically, over half those injuries occur while already in the hospital).

The FDA knows full well that when a drug is approved for the market the full extent of the side effects won't be known for years. History shows us time and again that Big Pharma actively hides risk data from the FDA and pays for "science" that distorts reality. This irresponsible behavior goes along with closed-door negotiations with the FDA, and has resulted in numerous drug disasters like Vioxx. FDA managers oftentimes go against the wishes of their own safety scientists and then move on to six figure salaries in the industry they regulate. Doctors are not apprised of the actual risks and consumers are in the dark.

to sue if they were injured, has almost nothing to do with consumer safety. Rather, it is a federal power grab that is in the best financial interests of Big Pharma and Big Biotech, industries that do not have consumer safety as their top priority.

By the way, don't think President Obama is on the side of the citizens. In the health care section of the stimulus bill, there is specific pre-emption language. If the federal government is in charge of health care it will be named in future lawsuits when patients are

injured from the care it doles out or doesn't allow.

The current Supreme Court ruling will undermine any system of federal health care wherein the drugs being used are injuring people. Experts believe this system is so badly broken,

due to gross FDA management incompetence, that it will take 10 years of studies and many billions of dollars just to understand the actual risks of the drugs Americans are already taking.

In writing for the majority, Justice John Paul Stevens put Big Pharma on notice. The defendant in this case, Wyeth, had argued that it could not comply with both federal and state law. Stevens told them they had a fundamental misunderstanding of regulation and were trying to hide behind the FDA, going on to say that it is a central premise of federal drug regulation that the manufacturer bears responsibility for the content of its label at all times. That is not the news Big Pharma wanted to hear.

Stevens went on to write that there was no merit in the argument that the FDA's labeling decisions could supersede state law, saying that this argument was "an untenable interpretation of congressional intent and an overbroad view of an agency's power to pre-empt state law." He pointed out that the FDA tried to push this on the public without any opportunity for comment from the public or from states, all done against a backdrop wherein the FDA is not able to keep up with safety issues in the first place, meaning that the FDA position lacked "thoroughness, consistency and persuasiveness." Stevens stated that under such lacking standards the Bush position "is entitled to no weight."

healthier from drugs and surgery, but they sure are becoming increasingly bankrupt.

The "grand clinical trial" of medicating an entire nation and observing the results has proven quite conclusively that *drugs and surgery do not produce a healthy nation.* That's the one drug trial they will never report, of course: While people suffer from skyhigh rates of degenerative disease, depression, obesity and chemical

themselves, some of the most dishonest and despicable human beings to ever walk the planet.

It is no exaggeration whatsoever to say that if the entire drug industry shut down tomorrow, and all the doctors went on strike, and all the oncologists overdosed on chemotherapy and

In a unique approach, "America's Riddle King" Mike Thaler helps kids differentiate truth from tradition this season with his new book, *Easter Egg Haunt*. One of four books in his "Tales from the Back Pew" series, *Easter Egg Haunt* gets kids laughing as Thaler sets the record straight about all things Easter.

An unlikely providence: SBTS grad ready to serve as Red Sox chaplain

BOSTON (BP)--The Boston Red Sox did not sign a big-name free agent this winter to help them fend off the hated New York Yankees in the American League East during the upcoming season, but the clubhouse presence of a man who batted .080 in his last year of organized ball could make a significant impact on the team in 2009.

Bland Mason, a two-time graduate of The Southern Baptist

Theological Seminary and New England church planter, was named chapel leader for the Red Sox in January by Baseball Chapel, a Christian organization that has an informal relationship with Major League Baseball and places chapel leaders with each team.

Mason, who received his master of divinity from Southern Seminary in 1997 and his Ph.D. in 2005, seems to be the

most unlikely of candidates to serve the Boston Red Sox; after all, Boston is a Red Sox-mad city with fans that number among the most ardent and baseball-savvy in America, able to sniff out a historically naïve, Johnny-comelately fan from 100 paces.

Mason has been a Boston citizen exactly four months and prefers basketball to baseball, having last played the latter in fifth grade, concluding his brief career with a batting average of .080.

Recently, the Red Sox new chaplain encountered a friend wearing an Atlanta Braves cap with the trademark "A" emblazoned across the front. Mason asked his friend if he was a fan of the A's — as in Oakland. While he is not ready to dominate at baseball trivial pursuit, Mason points out that God's ways often confound the wisdom of the wise.

"I have cheered for the Sox for the last five years and yes, I was touched somewhere deep in my soul when they won the World Series in 2004," he said. "With all of that said, as of November of this year I could not have named more than six or eight players on the Sox roster. found him. A friend in the Acts 29 church planting network was offered the role, but could not fill it; he recommended Mason and Baseball Chapel contacted him. Mason and his family are laying the groundwork for a church plant in Boston.

As a chaplain, Mason's duties include serving the spiritual needs of the Boston players, both those who play for the big league club and those in the minor leagues. Each Lord's Day, he will lead

chapel services for both the Red Sox and the visiting ball club and will offer Bible studies for players during the weeks when the Red Sox are playing at Fenway Park.

Baseball chaplaincy offers a profound opportunity to minister to players who play a rigorous 162game schedule of daily games, a schedule that consumes most every minute of their time for more than six months, Mason points out.

Half of the games are on the road, meaning players are seldom at home with their families and games are scheduled for each Sunday, meaning Christian players seldom worship in their local congregations.

"Most of the players are not from Boston and only live here eight months out of the year," he said. "Combine that with the fact that they have the most games of any major sport means that the Christians on the team don't get to their home church most of the year."

"I can offer Bible studies during a home stint for those players that Sports

Since Mason took the position a little less than two months ago, he is getting acquainted with the Christian players who populate the Red Sox roster.

Mason and wife Teresa joined the Red Sox last week at their spring training camp in Fort Myers, Fla., where he met two players who were off-season acquisitions, both of whom are strong Christians: former Atlanta Braves pitcher John Smoltz and catcher Josh

Bard, formerly of the San Diego Padres. Both are active in Baseball Chapel. Mason has also met Justin Masterson, a second year pitcher and follower of Christ.

Not only will Red Sox players receive discipleship from Bland Mason, but Teresa Mason has also accepted a position with Baseball Chapel as a women's leader and will work with wives and girlfriends of players.

Though it seemed a bit of an odd fit at first, Mason is embracing with vigor the new calling that God has given him to minister to the Red Sox through the ministry of Baseball Chapel.

"I have been reminded that God delights in working things out according to the counsel of His will, despite what we may think. If I can use my sanctified imagination for a minute, I think God smiled when he lined things up and I got the call offering the position to me," he said.

"I honestly had never remotely considered the idea of being a chapel leader to a major league team...I am reminded of something Jesus said: 'Oh how small is your faith!' Knowing that I would have dismissed it, God went one step further to get me in place: have a friend call me. God showed once again that His providence will guide us exactly where we need to be when we need to be there."

"As I begin laying the foundation for a new church here in Boston, it excites me to have the opportunity to serve the Red Sox. The position will afford me instant credibility with Christians and the unchurched across Boston. Teresa will have the great opportunity to minister to the players' wives as well."

"Add into this mix the fact that I just moved to Boston in November of this year and it makes complete sense why I wouldn't be a good candidate for the position as a baseball chapel leader to the Red Sox. I mean, who would want a very modest Red Sox fan who just moved to Boston and never played baseball beyond little league to serve as the chapel leader to the Red Sox? It seems that 'God' is the only answer to that question because logically it just doesn't work otherwise."

A native of Gloucester, Va., Mason did not find the chaplain position; consistent with the theology of his Puritan heroes, it are ready or interested. Within that group there are usually one or more players that are open to being discipled on a personal level. My prayer is for God to allow me to equip and encourage these guys to grow in the Gospel in every area of their lives."

derogatory comments: "they're all crack heads, lazy, abusers, thieves, dirty," and so on.

You learn that people in glass houses really *do* throw stones. Thus, your resolve quickly erodes into apathy and you gradually forget your outdoors experiment and your empathy.

One of the things that struck me when I first saw *Hope* City is the irony of the tall downtown buildings that dwarf the encampment. The Hampton Inn Luxury Suites are a few minutes walk away and not much further are the Biltmore, The Westin and other fancy eating and sleeping establishments.

Cars whiz by; many of the drivers are oblivious, while other carloads gawk at the sight. Some of the "campers" can be seen moving about in the shadow cast by the bridge. On a sunny day, they might be on lawn chairs soaking up the rare natural warmth. In any event, it is indeed an odd sight to see camping in a downtown area.

A five-foot long cross composed of rocks is shaped on the ground under the bridge; a memorial placed on the spot where a homeless gentleman, Paul Langlais, died in January. He is one of thirty who have died on the streets in the last year or so.

John Joyce refers to Hope City as the "Community." Three years homeless, he said that he "could not believe the injustices" everywhere when he first hit the streets. There is a lack of continuity that prevails and "everything comes down to the almighty dollar."

Determined to help change things, John began to attend meetings and join committees but, he said, "There were meetings after meetings but there was no action. There was nothing getting done; there was no change."

Recognizing the scarcity of case managers and outreach workers in the overburdened shelter system, John began to advocate for people on his own. Not only did he provide direction and support but he also studied the regulations governing the shelters and other agencies so that he could effectively intervene and advocate when a persons rights were abused.

It was at one of these meetings that John met Megan Smith. Megan, a twenty-one year old Urban Studies and Public Policy major at Brown University joined forces with him. Megan had a strong interest in homeless issues and was an active member of the Brown student group, *Housing Opportunities for People Everywhere* (HOPE) for over two years.

Together this dynamic-duo began to do some outreach on the streets. As they did, they were appalled at the lack of case managers. Even one of the largest homeless organizations, the one with the most case managers, is overwhelmed by the increasing numbers entering the



system.

John and Megan saw, first hand, the difficulties and challenges facing people forced to survive on the streets or in the shelters. People sleeping in the

streets are "Seldom seen and largely ignored," said John. It is also not safe. People are "messed with," and sometimes robbed of their belongings while they sleep. There are often security problems in shelters, they simply cannot afford the number of people needed to oversee everything.

Megan related that "Something needed to be done; the city and the state are not stepping up. There needed to be a safe place, where people could

> sleep together in the same area and watch out for each other; a sense of community was necessary." On January 24th of this year, the first tent and some supplies arrived at the site. John, Megan, and six other cold people shared the tent. There

are now a dozen tents and 15-20 residents living there.

Megan said that it was quite interesting setting up Hope City with "A budget of zero." John Joyce says that it is the "Faith-based Community" that has sustained them in many ways. For instance, a few days after they set up, a church provided an out house.

John also said that prayers are answered. Very short of water, they prayed hard and ten cases of water

This is especially suitable when a person is worried and overwhelmed about things; a poignant description of God's amazing love and protection for us all. Why worry when *He* is at the helm?

John and Megan recognize that Hope City is not a solution. What is needed is affordable housing, more case managers and program assurances that are enforced so that the shelters are safe. There is a need for *outreach* case managers that come to the streets to visit people who can't or won't use the shelter system. Homelessness, John reminds us, "is not a 9-5 job."

Megan says that much of the problems have to do with "bad public policy." She describes this as "Policy that does not take into

prevention programs and more."

The budget, "Is balanced on the backs of the poor", Megan said. She's right; items such as the capital gains tax and tax codes have advantages built in for the very wealthy. It is "So easy to disassociate oneself and view the problem in

an analytical ivory tower than to actually engage in the situation"


"How can you make public policy, she wonders, when you don't come out to talk to the people? Everyone here (at Hope City) is articulate and willing to share their views." She, in fact, wonders why reporters are always interested in speaking with her instead of those in the community.

While there I had the opportunity to speak with Jeff Mayer for a few moments who offered similar insight, followed by a man named Bruce. Bruce admits to readily falling back into the same trap of addiction to alcohol but has coined the phrase, his favorite: "A set back is only a step up for a come-back."

Affordable housing, which could be made available right away, has not materialized, mainly because of political aspirations and other motivations that keep it from happening, said John. Among the people in the homeless community there are many skilled laborers, including carpenters, electricians, plumbers and other talented people who are willing to volunteer to renovate houses which are currently sitting abandoned.

So there you have it. I realize that it would be unrealistic for you to drop everything to live in the elements or to write a huge check to alleviate some of the problems, but your silence is deadly. Here is an opportunity to speak up and make your voice heard:

They have recently been quite moved by a mother of seven children who prepared sandwiches with chips and drinks for them and then returned with coffee. Aside from friend and advocate, John also provides scriptural wisdom to his peers. 

Hidden Treasure: The Boat the Vatican Sought

In 1986, two brothers, Moshe and Yuval Lufan, found something beyond all expectations. According to Pastor Skip Heitzig, who has recently finished filming a documentary on the find, the brothers felt that they would discover something wonderful on that day. And wonderful it was. Tucked away in the northwestern shore of the Sea of Galilee, the brothers unearthed a 1st century boat, now named the "Jesus Boat."

Heitzig explained to me in a recent interview that in 1986 there was a tremendous drought in Israel.

Since the boat's discovery, the Pope came to view the vessel, hoping it needed a home in the Vatican. The President came to see it, as did many other men of science and politics. For the past few years, the "Jesus Boat" has generated great interest across the world.

In as much as Heitzig finds the boat a fascinating and important archeological discovery, he also sees the boat as a picture of more than an ancient sailing craft. In the boat, Heitzig finds a parallel to the nation the boat was discovered in.

This allowed the brothers access to deeper regions of the lake. One of the brothers stumbled upon some wood, and after a little digging, determined that the wood was actually a boat. According to the brothers, a double rainbow revealed itself in the sky after the find.

The brothers retreated to the Kibbutz Ginasar to get help. The Antiquity Authorities were brought in. After a long, 12-day archeological excavation (the boat was kept in a preserving environment and sailed across the Galilee river), the "Jesus Boat" was put in a 7-year chemical bath (a wax paraffin, Heitzig explained) before it could be displayed in the open air.

Since the time of it's unearthing, the boat has been officially dated to the 1st century. Almost 27 feet long, and over 7 feet wide, the boat was dated based upon the nails used and the construction of the hull. Most scholars agree that the era during which the boat was built falls somewhere between 100 B.C and 100 A.D.

in 1948. He reemerged it as a bud for a new generation, and established Israel as a nation.

In the soon to be released documentary, "The Jesus Boat", Heitzig as host, takes viewers on a journey through the discovery, preservation, and display of the boat (the boat can be seen in the Yigal Alon Museum in Kibbutz Ginasar), though Heitzig makes it a point to draw a strong parallel to the rebirth of the Nation of Israel.

According to Heitzig, "The Jesus Boat was way more than a documentary about an ancient boat. It's really a testimony to the faithfulness of God. Through the film, we paralleled the story of a lost boat and a lost nation, Israel, both of which were "resurrected" after 2,000 years. It tells of a boat that wouldn't stay buried in a land that couldn't stay buried!"

"Just like the boat was buried under the shores for 2,000 years, the land of Israel was submerged - virtually not a nation - a dispersed people group. Yet against all odds, Israel re-emerged in 1948. As the prophet Ezekiel predicted, there was a re-gathering of Jews from the four corners of the world into that ancient piece of real estate. It would seem as impossible as dried bones, bleached and parched under the Middle Eastern sun, coming to

life again." (See Ezekiel 36-37).



The world of communication was revolutionized by a man who died APRIL 2, 1872. His name was Samuel F.B. Morse, inventor of the telegraph and the Morse Code. An outstanding portrait artist in his own right, founding the National Academy of Design, Morse erected the first telegraph lines between Baltimore and the U.S. Supreme Court chamber in Washington, D.C. The first message over this new communication system, sent in 1844, was only four words, a verse from the Bible, Numbers 23:23: "What hath God Wrought!" Samuel F.B. Morse, who graduated from Yale in 1810, was the son of educator Jedediah Morse, known as "Father of American Geography." Jedediah Morse stated in Charleston, Massachusetts, April 25, 1799: "Whenever the pillars of Christianity shall be overthrown, our present republican forms of government, and all the blessings which flow from them, must fall with them." Four years before his death, Samuel F.B. Morse wrote: "The nearer I approach to the end of my pilgrimage, the clearer is the evidence of the divine origin of the Bible, the grandeur and sublimity of God's remedy for fallen man are more appreciated, and the future is illumined with hope and joy."

Day Gardner, president Of the National Black Pro-Life Union submits this statement regarding the anniversary of the decision of the Supreme Court/Dred Scott Case:

strict interpretation of the Bible. Wilkerson never has been prone to the fads and trends in Christianity. He is solid. That's why we need to take note of his email.

Wilkerson warns, "An earth shattering calamity is about to happen. It is going to be so frightening; we are all going to tremble, even the Godliest among us." Wilkerson writes, "There will be riots and fires in cities worldwide. There will be looting-including Times Square, New York City. The reasoning in Dred Scott and Roe v. Wade is nearly identical. In both cases the Court stripped all rights from a class of human beings and reduced them to nothing

more than the property of others.

In the Dred Scott case of 1857 the SupremeCourtsaid: Dred Scott was not fully human. He was the property of his owner -- and therefore he had no rights at all. The Court stated that because Dred Scott was not deemed "fully human", he could be bought, sold or even killed at the owner's discretion.

In the Roe v. Wade case of 1973 the Supreme Court said the same thing: A baby is the property of his/her mother -- and that he/she is not fully human, therefore he/


Timothy 1:7 says, "For God has not given us the spirit of fear; but of power, and of love and of a sound mind." she has no rights at all. The Court stated that because an unborn baby is not deemed "fully human" he/ she can be bought, sold or even killed at the mother's whim.

The Dred Scott Decision implied that even if slavery is cruel and degrading, slaves are not human and so their suffering is as ethically important or unimportant as the suffering of domestic animals and they do not have any rights that would justify the abolition of slavery.

There are also those heartless people today who say while abortion is cruel and gruesome, babies are not wanted, therefore their suffering is unimportant or even less important than the suffering of domestic animals and therefore do not have any rights that would justify ending the atrocity of abortion.

In the Court's eves, unborn

He is risen!

"He was oppressed and afflicted, yet he did not open his mouth; He was led like a lamb to the slaughter, and as a sheep before her shearers is silent, so He did not open his mouth." (Isaiah 53:7)

"Behold the Lamb of God, which taketh away the sin of the world."(John 1:29).

Good Friday, I'm still not sure why we call it "Good Friday," because this is the day in which Christians around the world commemorate the crucifixion of our Lord and Savior Jesus Christ.

Crucifixion was an ugly practice. There was and is perhaps no more painful way to die. And that's how Jesus chose to die to pay for our sins. According to the prophet Isaiah, who foretold His death, Jesus was scourged, tortured and marred more than any other man. Nails through the hands, nails through the feet and a crown of thorns puncturing His head, Jesus was whipped; His torso was pierced with a spear.

That hardly sounds like a Good Friday to me.

Personally, I think we should drop the Good Friday name along with the name of the holiday that follows on Sunday. Easter, too, is a lousy name for a very good holiday – in fact, I would argue, the most important holy day on the Christian calendar.

Why is Easter a bad name? Because Easter was a pagan festival. And we celebrate it today – with Easter bunnies and eggs and other fertility symbols – much like the ancient Saxons marked it in the pre-Christian period.

So, without belaboring the issue, I say we should drop the "Good Friday" stuff and rename Easter "Good Sunday." That would make sense; since it is the day we Christians rejoice that Jesus is alive and risen from the dead – our conquering Savior from all sin. It is a good day, indeed – the best day of the whole year, the best day in the history of man.

Easter, or, should I say, Good Sunday, is not about eggs, bunnies, flowers and springtime. It's about a Lamb – the Passover Lamb.

Remember what John said the day he saw Jesus coming toward him at the Jordan River? He proclaimed Jesus the Lamb of God, Who takes away the sin of the world.

John was a Jew. Jews traditionally, since the time of Moses, sacrificed an unblemished lamb at Passover. The First Passover for the Jews came in Egypt, when they were instructed to mark their doorways with the blood of an unblemished (or sinless) lamb. This sign protected them from the angel of death – sent to Egypt to claim the lives of all first-born sons – because it *passed over* their homes and moved on to homes not marked with blood.

And here was John – recognized by many in Israel as a young prophet – saying that Jesus was the "Lamb of God, Who takes away the sin of the world."

Indeed, Jesus is the Lamb. He was the first-born Son of God. His blood was shed for us. God did not spare or protect His own Son, but

spared us – those He loves and who love Him – by having Jesus be the pure sacrificial Lamb, who not only protects us from the angel of death for a time, but for eternity.

It may be a coincidence that Jesus' death and Resurrection coincided with pagan fertility rites. But it is certainly no coincidence that His death and Resurrection occurred around the Jewish feasts of Passover and unleavened bread. Jesus is the Passover Lamb, and He is the Unleavened Bread.

The true meaning of the Feast of Unleavened Bread was brought home to Christians by the Apostle Paul, who wrote, in 1 Corinthians 5: 7-8, "Get rid of the old yeast that you may be a new batch without yeast – as you really are. For Christ, our Passover Lamb, has been sacrificed. Therefore let us keep the Festival, not with the old yeast, the yeast of malice and wickedness, but with bread without yeast, the bread of sincerity and truth."

Yeast represented sin – through decomposition and fermentation. Once we are freed from sin through the blood of Jesus, we are then encouraged to avoid the old sin ways.

Today, many so-called Christians have forgotten their Jewish roots. They don't understand the symbolism and message of the Jewish feasts. They don't get the relevance of the Old Testament. They don't grasp that they are spiritual adoptee children of Abraham. Some today even fail to acknowledge that Jesus Himself was Jewish – a rabbi, who came not to destroy the law but to fulfill it. But, then again, maybe such folks are not really Christians at all.

In some European countries today, they still call Easter "Pascha" – a much better name. This is derived

BABY PICTURES MINISTRY TIP By Rev. Doug Forbes

Everyone loves to look at baby pictures. Viewing Baby Pictures brings a smile to our faces and a flood of happy memories. This activity will help your students get to know each other better and encourage friendships.

For the Baby Pictures activity you need: Bibles, Bible concordances, 3" X 5" cards, glue sticks, pens, baby and current photos of your students and a good copier.

A week before the Baby Picture activity gather one baby picture and one current picture of each class member. Using a photocopier, make 3" X 5" or smaller copies of each picture so that there is at least

one set of photos for each student.

Ask your students to use their Bibles and concordances to discover stories about or references to babies in the Bible. Allow time for each child to share his or her findings with the class. Have your young people turn to Exodus 2:1-10, and ask for volunteers to each

from the Hebrew word "pesah," which means "passover." Jesus was celebrating the Jewish festival of Passover shortly before He was arrested and sentenced to be crucified. Passover recalls how God rescued the Jews from slavery in ancient Egypt. Christians believe that Easter, like Passover, is a time of rescue. We say that by His Death and Resurrection, Jesus rescued us from eternal death and punishment for our sins.

That's why I will be rejoicing this Sunday – Good Sunday. And that's why even on a Bad Friday, I still have hope.

if even one of our sins remained on Him. God's eyes are too pure to look upon sin, remember? He'd have to turn away again and banish His Own Son from His Presence forever.

Since Jesus took all of our sins upon Himself, it follows that His death had to absolutely and forever pay the complete penalty for every one of them, or else He'd still be in the grave. So His resurrection is proof of yours. By believing in your heart that God raised Him from the dead, you're really telling God that you believe all the sins of your life were forgiven at the cross. With that alone you've inherited eternal life. Say a simple prayer like this:

Jesus, please forgive me. I know

read one verse until the entire passage has been read.

Discuss how God and Moses' family protected Moses in a most unusual Way! Talk about the little boat or basket that Moses was placed in. Discuss how God watches over us and protects us, and encourage your

students to share with the class a time when they felt God's protection, love and care.

Separate the children as much as possible, and give each child copies of their current and baby pictures. Have them glue a picture onto one side of each 3" X 5" card and write their name on the other side. (You may wish to have them share additional information such as their favorite sport or hobby.) Separate the pictures into two stacks, current photos and baby photos.

Have your assistant teacher or a parent give the children a snack while you organize the pictures into decks with the pictures facing up. Each deck should contain one current and one baby picture of each child. After the snack, give each student a deck of cards.

Explain to your students that they are to match up each baby photo with a current photo without looking at the back of the cards. The first one to make all perfect matches wins a small prize, such as an extra snack. (When working with younger children proclaim everyone winners and give everyone a prize.)

After class, allow the children to take their decks of photo cards home, and encourage them to play the match game with their parents or guardians. The photo cards will often be kept for many years, and they will bring back happy memories of your class whenever they are reviewed.

Believe in your Heart

If you confess with your mouth, "Jesus is Lord," and believe in your heart that God raised him from the dead, you will be saved. For it is with your heart that you believe and are justified, and it is with your mouth that you confess and are saved.

(Romans 10:9-10)

Jesus didn't die so that bad people could become good. He died so that dead people could live. When the Prodigal returned home, his joyful father didn't exclaim, "My son was bad and is good again" but, "My son was dead and is alive again!" (Luke 15:32).

The wages of sin are death, so prior to becoming believers we were all dead in our sins

in His righteousness forever. (2 Cor. 5:21)
Oh Yeah? Prove it!
God's eyes are too pure to look upon sin. (Haba 1:13) He liter-

ally can't stand the sight of it. Discovering this fact about Him helps us understand the importance

This verse is the bottom line where salvation is concerned. In case you've never noticed, it's always a matter of the heart with the Lord, and in this passage it's clear that the central issue of salvation is a heart-felt belief in the Resurrection. Why? Because it's how we're justified. The Greek word for justified comes from a root meaning "to regard as innocent." So, if we confess (agree) that Jesus is our Lord and believe in our hearts that God raised Him from the dead He'll regard us as innocent of all charges and qualify us for eternal life.

How Can This Be?

First, it helps to remember that

(Ephes. 2:1). But when Jesus

went to the cross He took all our sins upon Himself. (**Col. 2:13-14**) That means He agreed to accept the full punishment that was due us so that the charges against us could be dropped and we could escape the death sentence. Simply put, He made it possible for our Father in Heaven to exclaim, "My children were dead and are alive again!"

And His act of sacrifice wasn't only retro-active, paying back for all the sins of our pre-Christian lives, it was also pro-active, paying forward for all the sins we'll commit during the rest of our lives too, ... because by one sacrifice he has made perfect forever those who are being made holy. (Hebr. 10:14) Put another He places on believing in the

resurrection. On the cross, Jesus became the physical embodiment of our sin. For the first time ever the Father had to turn away from His Son leaving Him alone and in anguish to cry, "My God, My God, why have you forsaken me?"

Insulted, spat upon, beaten, whipped to within an inch of His life, and finally nailed to a cross, this was the only part of His entire ordeal that caused Him to cry out. The Earth shook and the sky went dark as the Light of the World was extinguished. (Matt 27:46)

Three days later Jesus rose from the dead to sit at the right hand of Majesty, and He's sitting there today. That wouldn't be possible




